



RELEASE OF LIABILITY, ASSUMPTION OF RISKS, AND INDEMNITY AGREEMENT

At **Fazenda Barranco Alto** in the Brazilian Pantanal, we make every effort to ensure the safety and enjoyment of all guests. The Pantanal is a natural, wild, and unpredictable environment that involves inherent risks. For this reason, all guests are required to sign this Assumption of Risk, Release of Liability, and Indemnity Agreement prior to arrival.

Please read carefully:

I am voluntarily participating in wildlife safaris and related physical activities offered by Fazenda Barranco Alto.

I understand and acknowledge that my participation in these activities—including staying at Fazenda Barranco Alto facilities and lodging, touring the property, using its equipment, riding in motorized safari vehicles, using boats and canoes on potentially dangerous waters, boarding and disembarking from vehicles, walking, horseback riding, mule riding, observing wildlife in an undeveloped natural environment, and traveling on primitive dirt roads and trails—may be hazardous and involves numerous risks of personal injury or death.

I am aware that there are large predators and potentially dangerous wildlife in the Pantanal capable of injuring or attacking humans, including jaguars, pumas, buffalos, caimans, anacondas, and others. I am also aware that all waters may contain dangerous fish such as piranhas and stingrays.

I understand that any interaction with horses or cattle may be extremely dangerous and potentially life-threatening, and I accept full responsibility for any involvement in horseback riding activities.

I agree that the use of life jackets is mandatory during all water-based activities.

I acknowledge that I am fully responsible for my personal belongings and equipment—including cameras, lenses, phones, and binoculars—and that Fazenda Barranco Alto shall NOT be held liable for any loss or damage to such items.

I freely assume all risks and acknowledge that I have been fully informed of the inherent hazards associated with being present on or touring Fazenda Barranco Alto.

I agree to comply at all times with instructions given by guides or staff members. I understand that failure to follow instructions may result in injury, permanent disability, or death, and may also result in my removal from the activity.

I certify that I have adequate insurance to cover any injuries or rescue/evacuation (including by airplane) that may occur during activities at Fazenda Barranco Alto. If not, I agree to personally bear all associated costs. I understand that in the event of an accident, rescue and medical assistance may not be immediately available. I certify that I am voluntarily assuming any risks associated with my physical or medical conditions.

I acknowledge that Fazenda Barranco Alto and its employees are not responsible for any transportation services, including vehicles or aircraft, used to travel to or from the property. These are third-party services and must be paid separately from Fazenda Barranco Alto services.
